Sealed bids are invited from reputed firms for "Demolition of existing reinforced concrete wall in the garden adjoining the Consular Wing to extend garden area at Embassy of India, 13-15 rue Alfred Dehodencq, 75016 Paris .

- 2. The bidding companies/firms should have:
  - i) Experience of undertaking work of similar nature in France in the last 10 years.
  - ii) Having a registration in France including Siret Number and VAT account in France.
  - iii) Local representation in Paris or suburb of Paris, France.
  - iv) The work consists of removing fences erected on the wall, breaking of reinforced concrete wall of 1.20 m height, disconnection and removal of any electric cables, power points or other services lines in the wall being taken down, modifying existing security cameras, lighting and power supplies to cater for the enlarged area, creation of 2 poles for cameras, protection of lawn and removal of gravel etc.
  - v) The successful bidder has to deposit Performance security which will be a sum equivalent to 10% of the accepted contract value in favour of Embassy of India, Paris in form of Banker's Cheque, within 15 days of the acceptance of the LoA (Letter of Acceptance). Performance Security should remain valid for a period of 60 (Sixty) days beyond the date of completion of all contractual obligations. In case, the contract is further extended beyond the initial period, the Performance Security will have to be renewed accordingly. No interest shall be paid on Performance Security. The Performance Security will be forfeited by order of Competent Authority in Mission in the event of any breach or negligence or non- observance of any terms & conditions of the contract or for unsatisfactory performance or for non-acceptance of the work order.
