 - **Bid Security/Earnest Money Deposit** The amount of bid security/EMD shall be (i) a) In case of Indigenous Bidder : Rs. 2,50,000/- (Rs. Two Lakh Fifty Thousand Only) In case of Foreign Bidder: USD 3000 (USD Three Thousand Only) or equivalent amount b) in other Foreign Currency (ii) If the bid security is NIL or Bidder is claiming exemption as per provisions specified in the Tender document then the bidder has to give Bid Securing Declaration as per format specified in Chapter-8: Annexure- D.
