## **INTERNSHIP VISA**

## PEOPLE ELIGIBLE FOR INTERNSHIP VISA:

- The Internship Visa will be granted immediately after completion of graduation/ post-graduation (masters level) but the gap between the completion of graduation/ post-graduation and the commencement of the internship should not be more than two years.
- The internship visa will be granted to persons wishing to travel to India as part of a VIE program. We will accept complete files only (list of documents given by BusinessFrance).
